### **DIRECTIONS**

### **BACKGROUND**

- (1) These directions are supplemental to my directions of 12 February 2019 and are made concurrent with my directions in application LON/00BG/LVM/2019/0010, Mr Coates application for his discharge as manager of the Estate.
- (2) Since my directions of 12 February 2019, the tribunal has received confirmation from 54 residential leaseholders that they wish to be joined as interested persons to this application. All 54 are represented by the Residents Association of Canary Riverside. Of those 54, 37 leaseholders indicated that they wanted to attend the final hearing of the application. 18 indicated that they did not wish to do so. The maximum number of persons the tribunal can accommodate at a hearing is 30 (including representatives). RACR are requested to confirm, as soon as possible, how many of the leaseholders it represents actually wish to attend the hearing. If it is likely to be more than 20 an alternative venue for the hearing will need to be identified which could result in delay in the determination of the two applications.
- (3) The tribunal has also received requests from the following to be joined as interested persons: Yianis Hotels Limited; Mr Christodoulou; and YFSCR Limited.
- (4) These directions will be sent by the tribunal to the representatives for the parties listed above. A copy should also be sent by Downs LLP to all leaseholders other than those represented by RACR Limited. They can be sent by email or if that is not possible by post.

### **DIRECTIONS**

- 1. By 22 March 2019 Downs LLP should send a copy of these directions and the directions of 12 February 2019 to all leaseholders other than those represented by RACR Limited. It may do so by email or, if that is not possible, by post.
- 2. The following are joined as interested persons to the application:
  - the 54 residential leaseholders represented by RACR as identified in the attached schedule;
  - Yianis Hotels Limited, represented by Freeths LLP
  - Mr J Christodoulou, represented by Freeths LLP; and
  - YFSCR, represented by Freeths LLP

- 3. Any other leaseholder who either supports or opposes the application for the discharge of Mr Coates and the appointment Mr Edwards may apply to the tribunal to be added as an interested person to this application and may do so by making such a request in writing to the tribunal, copying in Joseph Hage Aaronson LLP, the applicant's solicitors. Any such application should be made by **8 April 2019**.
- 4. The directions of 12 February 2019 should continue to be complied with by the parties.

# Hearing/inspection arrangements

5. This application will be determined together with application LON/00BG/LVM/2019/0010, during the three-day hearing on 4 – 6 June 2019 inclusive at 10 Alfred Place, London WC1E 7LR, commencing at 10am. If, at any time, a party considers this to be an unrealistic estimate, they should write to the tribunal (and send a copy to the other parties explaining why.

Original witness statements should be brought to the hearing. In addition, witnesses are expected to attend the hearing to be cross-questioned as to their evidence, unless their statement has been agreed by the other party. The tribunal may decline to hear evidence from any witness who has not provided a statement in accordance with the above directions.
